IMPORTANT INFORMATION – PLEASE READ CAREFULLY

REMINDER: Failure or refusal to follow any of the COVID-19 health and safety protocols may subject Credentialed Attendees to discipline, including removal from tournament facilities, hotel, and transportation.

Please read carefully the attached documents before your departure

DO NOT TRAVEL if your pre-travel test is **positive** or you have COVID-19 symptoms.

CURRENT TRAVEL RESTRICTIONS

Everyone entering Korea will need to present a NEGATIVE PCR TEST not longer than 48 hours from departure.

It is suggested all attendees to bring with them a copy of their valid **Proof of vaccination**, which is valid:

TESTING ON ARRIVAL

ALL PLAYERS AND PST MUST UNDERGO COVID-19 SCREENING AND PCR TESTING

TESTING LOCATION & TIME	At the airport, tournament staff will take you to the testing lab before getting on the official bus
TESTING EXPENSE	80,000 Korean Won (To be paid by each individual)
ANTICIPATED TURNAROUND	PCR within maximum 24 hours
	Fully-Vaccinated or Unvaccinated Credentialed Attendees must submit to a PCR Test upon arrival and will be allowed full access to applicable Tournament Facilities only AFTER a Negative PCR Test result.

POSITIVE TEST

IN THE CASE OF A CONFIRMED POSITIVE TEST	The player will immediately be withdrawn from the Tournament and the player will be required to isolate immediately and follow medical advice.
ISOLATION LOCATION MANDATE	Official Tournament Hotel
ISOLATION PERIOD & EXPENSE	7 days (All the extra expenses will be paid by the individual)

AFTER ARRIVAL AND BEFORE RETURNING HOME

RETURNING HOME OR CONTINUING TO PARTICIPATE OTHER TOURNAMENTS	If any proof of negative PCR results are needed after the tournament to go to some other countries, players will have to ask and submit to the organizer upon their arrival. The organizers will take the player to the appropriate testing facility and let him/her to take the test. If any kind of English written documents are needed, each players will have to pay their own expense which is about USD100 .

COVID-19 GENERAL TESTING INFORMATION AND REQUIREMENTS

REASONS FOR TESTING PRIOR TO TRAVEL:

- * If PCR positive before travel, you will be able to isolate and recover at home rather than being forced to quarantine in a foreign country.
 - * If PCR positive and you travel, there is an increased risk of infecting others.
 - * If PCR positive upon arrival, you will not be able to compete.
 - * If your pre-departure PCR test is positive or you have any signs or symptoms of COVID-19, you **must not travel to** the tournament and should contact your healthcare provider.
- Fully-Vaccinated Credentialed Attendees are still required to submit to PCR Testing as per current testing protocols in place.

PRE-DEPARTURE NEGATIVE COVID-19 TEST RESULT REQUIREMENT FOR INTERNATIONAL ARRIVAL(from JUN 27, 2022)

- ◇ All travelers entering the Republic of Korea are required to submit pre-departure negative COVID-19 PCR test(or a supervised Rapid Antigen Test)results upon arrival.
 - Travelers without a valid test result will be prohibited from boarding the flight.

1. Requirements

Category	Requirement
① Test type (Method)	<ul style="list-style-type: none"> ▶ It needs to be based on nucleic acid amplification tests (NAATs). * Either a supervised Rapid Antigen Test (RAT) taken at a hospital or clinic, or DNA amplification-based PCR test (RT-PCR, LAMP, TMA, SDA or NEAR, etc) is valid. * All forms of self-administered tests are NOT valid regardless of test type.
② Time of testing and issuance of PCR(RAT)negative certification	<ul style="list-style-type: none"> ▶ The test must be performed and the PCR negative certificate must be issued within 48 hours (two days) before the departure date. - A supervised negative COVID-19 RAT result must be issued within 24 hours prior to the departure date. * (Example) If you are departing from a country to Korea on May 23, 2022 at 10:00, you must submit your negative PCR test result taken after 00:00 on May 21, 2022 or supervised negative RAT result taken after 00:00 on May 22, 2022.
③ Required items	<ul style="list-style-type: none"> ▶ Name*, date of birth**, test method, test date, test result, date of issuance, and name of testing center should be included in the test result. * The name on the test result needs to match the name on the passport (middle name can be omitted as long as the other names are identical) ** Passport number or national ID number is acceptable in lieu of date of birth
④ Test result	<ul style="list-style-type: none"> ▶ The test result must be NEGATIVE. * If the test result is "INDETERMINATE", "UNCLEAR", or "POSITIVE", the relevant result is invalid.
⑤ Language	<ul style="list-style-type: none"> ▶ The test method must be written in Korean or English. * If the test method is written in a language other than Korean or English, a translated copy of the test result in Korean or English needs to be submitted together with a certificate of translation. (If the test result was translated by individual translators, the translated document needs to be certified by a notary office or Korean embassy.)

※ Make sure to check the arrival procedure for each country on the websites of diplomatic missions abroad prior to departure (<http://overseas.mofa.go.kr>).

2. Those who are exempt from the requirement of submitting a PCR(RAT) negative certificate(Responsible for proving yourself*)

- Children under 6 as of the date of arrival (only if all the accompanying persons traveling with the child have submitted valid negative test results)
- Individuals with quarantine exemption certificates for humanitarian(attending funerals) or [official business reasons](#)
- Flight crew(who arriving for air operation)
- Individuals who departed from Korea for another country but were denied entry or otherwise did not go through with the entry procedure at another country before returning to Korea. This applies to both Korean nationals and foreign nationals, and the burden of proof is on the traveling individual.
- Korean nationals entering Korea within 10 to 40 days of the date when they tested positive for COVID-19*
 - * A DNA amplification-based test such as a PCR test or supervised RAT taken in Korea is accepted, but from May 23, 2022, a supervised RAT taken outside of Korea will be also accepted.
- Foreign nationals on a long-term stay who had COVID-19 in Korea entering Korea within 10 to 40 days of the date when they tested positive for COVID-19, taking effect from April 11 (only applied to those holding at least one of the following: residence card, overseas Korean resident card, permanent resident card, ID card of diplomatic mission in Korea or USFK Common Access Card)
- ※ Even if those who are exempt from presenting proof of a negative COVID-19 test, if they develop symptoms of COVID-19, they are not permitted to board their flight.

3. Measures taken if a person does not submit a PCR(RAT) negative certificate, or if a submitted certificate does not meet the requirements

- **(Before entry)** If you do not have a PCR(RAT) negative certificate or have a certificate which does not meet the requirements, you will not be allowed to board the aircraft.
 - ※ A person who is exempt from submission of a PCR(RAT) negative certificate is allowed to board the airplane even if he or she does not have a certificate, or if the certificate does not meet the requirements.
- **(After entry)** Korean nationals and foreign nationals on a long-term stay must receive a PCR test at the public health center and wait for the test results at home(or dorm)
 - Foreigners on a short-term stay are not permitted to enter Korea.
