The **ipin** (International Player Identification Number) is brought to you by the International Tennis Federation, the world governing body of tennis.

All players who wish to compete in ITF Junior Circuit, ITF Pro Circuit, ITF Seniors Circuit or Uniqlo Wheelchair Tennis Tour tournaments are required to have a current IPIN Membership.

As well as allowing players to play in ITF tournaments, IPIN Membership provides access to the IPIN Online Service which helps you to manage your tennis career and keeps you up-to-date at all times! Pro Circuit players can also use the service to manage their tournament entries online.

You can obtain your IPIN Membership by paying the annual registration fee.

Please make sure you understand when your IPIN membership will expire before continuing.

### Introduction of a Therapeutic Use Exemption (TUE) Portal

From 1 January, all TUE applications must be completed using the new Tennis Anti-Doping Programme Portal. An account must be created in order to submit an application and all accounts are subject to verification.

Players are invited to create an account (which is a once-only process) as soon as possible, as this will help to minimise any delays in the processing of subsequent applications. Players are also encouraged to invite physicians who they anticipate are likely to submit an application on their behalf to create an account.

#### Match Fixing

Any agreement to alter the score or outcome of a match is a corruption offence



## Awareness

### Corrupt Approaches

Those who are aware of corrupt activity, but do not report it, can be penalised as though they had committed the offence.

All corrupt approaches received must be reported to the TIU. Failing to report is a breach of the anti-corruption rules.

Wild cards must not be sold or purchased. No form of benefit or compensation can be given in exchange for a wild card.

All persons covered by the TACP must inform the TIU if they have knowledge or suspicions that another Player, Covered Person or Tournament Support Personnel has committed or been involved in a corruption offence.

You must cooperate fully with any investigation conducted by the TIU.

Betting companies must not sponsor, employ or provide any other benefits to you.
